

Terms and Conditions of 'HSBC FlexInvest and Future Planner iPhone 16 Monthly Lucky Draw' ("Offer")

General terms and conditions

Specific Terms and Conditions for the Offer

1. The Offer is effective from 1 October 2024 to 31 March 2025, both dates inclusive (the "Promotional Period").

Who can enjoy the campaign ("Eligible Customers")?

2. The Offer is applicable to HSBC Premier and HSBC Premier Elite account holders with an investment account, residing in Hong Kong, and with a valid email address in our bank record.



3. HSBC Premier and HSBC Premier Elite account holder who have not invested through FlexInvest during 01 January 2024 to 30 September 2024, and who do not hold any funds with FlexInvest.

How to join the Offer?

- **4.** Eligible Customers must perform the two steps in clause 5 and 6 below to become eligible for the Offer.
- 5. <u>Step 1: Eligible Customers must set a retirement goal in Future Planner on the HSBC Mobile Banking</u>
 App during the Promotional Period:
 - (i) First-time users of Future Planner will be guided through steps to set up the service, including goal setting and filling in a financial profile.
 - (ii) Once completed, and for existing Future Planner users, Eligible Customers must review their retirement goal under the section 'my goals' by tapping on the **Retirement** tile, and edit their goal details by tapping the edit button at the top-right corner (pencil icon).
 - (iii) After reviewing the details, and by <u>clicking the **confirm** button</u>, Eligible Customers will have completed the Step 1 required to join the Offer.
- 6. <u>Step 2: Eligible Customers must invest at least HKD5,000 using FlexInvest to enter one of the lucky draw periods:</u>
 - (i) Eligible Customers must make subscription order(s) of at least HKD5,000 of one or across multiple funds through FlexInvest ("Eligible Transaction(s)")
 - (ii) The draws will occur once a month, over a six (6) months period. Eligible Transaction(s) must be placed within the lucky draw period (see clause 7, Table (I) for reference) to qualify for that month's draw. Transactions made in one month will not be carried over to the following month's draw.
