宏觀及市場回顧 Macro and market review



- 預期利率將會在較長時間處於高位，加上債券孳息率上升及企業盈利停滯不前，環球股市於九月下跌。政府債券方面，由於二零二四及二零二五年的利率展望上升，較長年期的環球政府債券急跌(孳息率上升)。另類投資方面，全球減產引發本月油價大幅上漲。美元轉強及實際孳息率上升，則令金價受壓而微跌，但過往一年仍錄得升幅。主要已發展及新興市場貨幣於本月均輕微轉弱

Global equities fell in September in response to expectations of 'higher-for-longer' interest rates, rising bond yields and stagnant growth in corporate earnings. Longer dated global government bonds fell sharply (yields rose) in response to a higher interest rate outlook for 2024 and 2025. For alternatives, cuts to global output triggered a sharp upward move in oil prices during the month. A strengthening US dollar and higher real yields muted the gold price, which fell slightly but remains positive over one year. Major developed and emerging market currencies were all slightly weaker during the month

The Federal Reserve (Fed) policy rate is likely at its peak as it balances its concerns surrounding lingering inflation against already meaningfully restrictive policy. We see the Fed cutting rates forcefully from the second quarter of 2024 as recession bites

- 鑑於通脹已逐漸放緩，加上經濟活動尤其低迷，九月份可能是歐洲央行最後一次加息。隨著經濟陷入衰退，預料歐洲央行將會大幅放寬政策，情況與美國相同

The September rate hike may be the European Central Bank's (ECB) last given already slowing inflation and especially sluggish activity. Like in the US, as the eurozone tips into recession, significant policy easing is likely

- 我們不排除中國將會進一步放寬貨幣政策，而當局亦須提供更多財政支持以維持經濟復甦步伐。與此同時，日本央行仍有可能會廢除孳息率曲線管控制框架

Further monetary easing cannot be ruled out in China, while more fiscal support is needed in order to sustain a recovery. Meanwhile the Bank of Japan still looks likely to dismantle its yield curve control framework

資產類別展望及策略 Asset class outlook and strategy



- 股票方面，對於已發展市場，隨著消費者耗盡積蓄，其消費能力正在減弱。相對於衰退風險而言，估值似乎亦處於高位。中國的周期性放緩仍是新興市場股票的主要風險，但若干板塊因估值吸引及宏觀經濟環境穩健而受惠

For equities in developed markets (DM), consumer spending power is diminishing as savings are exhausted. Valuations also seem elevated relative to recession risks. China's cyclical slowdown remains a key risk for emerging market equities, but there are pockets which can benefit from attractive valuations and macro resilience

- 政府債券方面，利率較長時間處於高位或會令債券孳息率於短期內高企。然而，我們始終相信主要已發展市場經濟體步入衰退是最有可能出現的結果，並會導致央行大幅減息，推高政府債券

For government bonds, higher-for-longer rates may keep yields elevated in the near-term. However, we ultimately believe recession is the most probable outcome in major DM economies, and that will lead central banks to cut rates aggressively, boosting government bonds

- 企業債券方面，鑑於對經濟增長的憂慮，加上違約風險的因素，息差有擴闊的空間，但由於資產負債表穩健，投資級別信貸能夠提供入息良機

For corporate bonds, spreads have room to widen given growth concerns and as default risks get factored in, but investment grade credits can provide good income opportunities given stable and healthy balance sheets

▼ 環球股票 Global Equities

假如中國經濟增長回升，且採納人工智能使生產力顯著提高，一些上行空間或會出現。然而，由於儲蓄耗盡、名義增長惡化和企業收緊開支，二零二四年的盈利預期似乎過高

There can be some upside should China growth pick up and if AI adoption leads to significant productivity gains. However, 2024 earnings expectations look too high given depleted savings, deteriorating nominal growth and corporate retrenchment

▲ 亞洲日本除外股票 Asia ex Japan Equities

宏觀不確定性、地緣政治、毛利率下降和盈利下調仍然是主要風險，但中國將推行更多政策維持增長動力，而亞洲央行的緊縮政策進取度降低或可帶來一些支持。地區市場形勢可能出現分歧

Macro uncertainties, geopolitics, margin erosion, and earnings downgrades remain key risks, but more policy rollouts in China to sustain growth momentum and less aggressive tightening by Asian central banks may offer some support. Dispersion in regional markets remains likely

▼ 美國股票 US Equities

估值稍為偏高，且人工智能的熱潮減弱。經濟衰退風險明顯，但似乎未有在價格反映；消費者儲蓄減少和信貸環境收緊可能使盈利能力受到挑戰

Valuations look somewhat stretched, with AI enthusiasm moderating. Risks of a recession are notable and do not appear to be priced in, with declining consumer savings and tighter credit conditions likely to challenge profitability

▼ 歐元區股票 Eurozone Equities

歐元區的經濟活動尤其乏力，雖然歐洲央行的利率可能已處於高峰，但通脹高企仍然令人不安，可能令利率保持在高位較長時間。這為股市帶來艱難的環境

Eurozone activity is especially sluggish, and while the ECB may be at peak interest rates, inflation remains uncomfortably high and is likely to keep rates higher-for-longer. This creates a difficult environment for equities

▲ 中國股票 Chinese Equities

房地產市場結構性地下行、國內外需求回軟及人民幣短期疲弱等因素，仍持續對經濟前景構成風險，但中國實施更多政策措施，加上估值相對吸引，或有助重振部分投資者信心

Although risks to the outlook still linger from a structural downturn in property market, softening domestic and external demand, and a weak short-term RMB, the implementation of more policy measures in China and relatively attractive valuations may help revive some investor confidence

▲ 香港股票 Hong Kong Equities

全球增長不確定性持續、中國的宏觀憂慮及國內房地產市場乏力，仍然是盈利前景的主要下行風險。但其估值向好和就業市場穩定，應有助抵銷部分負面因素

Lingering global growth uncertainties, the macro concerns surrounding China and the faltering domestic property market remain the key downside risks to their earnings outlook. But their compelling valuations and a stable job market should help partially offset some headwinds

債券 Bonds

■ 環球政府債券 Global Government Bonds

通脹風險持續，可能促使央行維持高利率較長時間。雖然短期內債券孳息率可能高企，但我們認為隨著經濟衰退風險變得清晰，各國央行可能開始減息，將有利債券表現

Inflation risks still linger and may prompt central banks to keep rates higher-for-longer. While this may keep yields elevated in the near-term, we believe that as recession risks crystallise, central banks may start to cut rates, boosting performance

▲ 美國政府債券 US Government Bonds

聯儲局上調增長預測後，主席鮑威爾確認高利率維持較長時間的預期。然而，目前的限制性政策尚未傳導至經濟，衰退和相關減息可能使債券孳息率在二零二四年稍後時間下降

Following an upside revision to the Fed's growth forecasts, Chairman Powell confirmed the expectation of higher-for-longer rates. However, current restrictive policy is yet to work through the economy, with recession and associated rate cuts likely to prompt falling yields later into 2024
